- Communicate code requirements to the public, contractors, and local officials

- Oregon Inspector Certification (OIC)
- Oregon Commercial Plumbing Inspector Certification
- Oregon Residential Electrical Inspector Certification
- Oregon Residential Structural Inspector Certification
- Oregon Medical Gas Plumbing Inspector Certification (within six months of hire)

Note: Successful candidate must obtain the required certifications within 60 days of hire.

- Effective verbal and written communication skills, occasionally with irate or upset individuals
